Costume Rental Agreement & General Rules

	1. AN ADULT MUST ACCOMPANY THE CARACTER AT ALL TIMES. BE THEIR EYES. GUIDE THEM, WATCH KIDS AROUND THEM, MAKE SURE THE KIDS AND PARTY PATRONS
	ADHERE TO ALL THE RULES.
	2. Most costumes have limited sight capability make sure the guide is with you at all times to be your eyes.
	3. Watch the areas the character is walking through. Make sure the path is clear of items and debris on the
	ground. Watch for doorway heights, narrow hallways, overhangs, ceiling fans, and anything else that may
	be a hazard as they move around.
	4. No smoking or fire around the costume at any time!
	5. No shoes only socks should be worn inside the costume footwear.
	6. No rough play around or directed towards the costumed character.
	7. No pulling on, or grabbing onto/or around the costumed character.
	8. No jumping on top of the costumed character
	9. No food, drinks, candy, or gum chewing in or around the costume.
	10. No sharp objects in or around the costumed character.
	11. Costumes are <u>ONE SIZE FITS MOST</u> . Do not force zippers or costume pieces on. If it doesn't fit find someone it will fit. If you have any questions or concerns give Jump N Jax a call @ (262) 654-3222
	12. If worn outside please be aware of dirty or muddy areas and avoid them always.
	13. Take an inventory of all costume pieces before and after use. Make sure all pieces are collected and put
	back into the costume bag. Any pieces gone missing or destroyed will be charged back to the customer.
